RE: Proposed Amendment and Adoption of Licensure of Suitable Facilities for the Performance of Surgical Abortions Rules – 10A NCAC 13S

GS 150B-21.2 requires a rule-making body to notify certain individuals of its intent to adopt a permanent rule. It also requires notification of the date, time and location of the public hearing on the rule and any fiscal note that has been prepared in connection with the proposed rule.

The North Carolina Medical Care Commission has submitted form OAH 0300 to the Codifier of Rules, Office of Administrative Hearings, indicating its intent to proceed with adopting all of the following rules:
