RE: Proposed Readoption/Amendment/Repeal of Radiation Protection Commission Rules 10A NCAC 15 .0501, .0608-.0609, .0802-.0803, .0901-.0910, .1001, .1601, .1901-.1911, .2001-.2011

GS 150B-21.2 requires a rule-making body to notify certain individuals of its intent to adopt a rule. It also requires notification of the date, time and location of the public hearing on the rule and any fiscal analysis that has been prepared in connection with the proposed rule. There are 39 rules in this rulemaking action. With input from advisory committees, working groups of the N.C. Radiation Protection Commission and stake holders, substantive changes are proposed for 10 rules for readoption with substantive changes, 5 rules for amendment, 2 rules for repeal through readoption, and 22 rules are proposed for adoption.

These rules are necessary to regulate the therapeutic use of accelerators (radiation generating devices) used to treat cancer and disease in people and in animals. Currently, the State regulates accelerators by blending outdated accelerator rules with the practice of applying and interpreting the Federal regulations used to regulate teletherapy machines using radioactive materials found in 10 CFR Part 35.600 for this purpose. The existing accelerator rules, 10A NCAC 15 .0608, .0609, and Section .0900 are inadequate and have not been updated since 1994. A couple have not been updated since 1980 when the rules were first enacted. Many changes in technology and therapy techniques have been developed over the last thirty-plus years. Using outdated accelerator rules to regulate the use of modern accelerators and applying rules developed for regulating the use of radioactive materials in an entirely different type of device is inefficient, confusing, and contrary to NC General Statute 150B-18: the agency is using a policy, interpreting rules from one technology to apply to a different technology, in lieu of rules for the technology being regulated.

The North Carolina Radiation Protection Commission has submitted form 0300 to the Codifier of Rules, Office of Administrative Hearings, indicating its intent to proceed with the following rule-making actions:

A public hearing is scheduled for May 1, 2025, at 10:00 a.m. in Room 026, Edgerton Building, 809 Ruggles Drive, Raleigh, NC 27603. The building is in Dorothea Dix Park. Ms. Shanah Black, DHSR Rule-Review Manager, is accepting public comments on these rules and fiscal analysis from April 1, 2025 through June 2, 2025, close of business. Comments will also be accepted in person at the public hearing. The proposed effective date of these rules is October 1, 2025.
